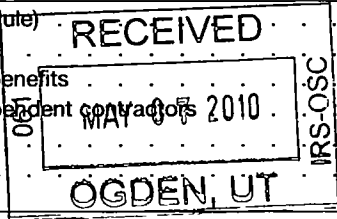

Part III. Statement of Program Service Accomplishments

Line 28. Safe Water for Families Program:

The objective of this program is to provide rural Haitian populations with a sustainable, affordable water treatment product in order to:

- a) Decrease the incidence of diarrheal disease

- b) Provide income for rural Haitians
- c) Provide consistent access to safe water.

Activities:

Rural Haitians pay for sodium hypochlorite, a household water treatment product which is produced in Jolivert, Haiti. This program served over 20,000 families in 2009 and is daily adding new families. Due to its success, Deep Springs has plans to replicate this program in Les Cayes as well as other areas of Haiti.

Line 29. Les Cayes School Program:

The objective of this program is to educate young adults in health and business in order to:

- a) Increase health knowledge throughout the greater community of Les Cayes as the students bring new information home to their families
- b) Increase business knowledge to enable youth to start their own enterprise
- c) Create demand for water treatment products through knowledge of health issues and available solutions.

Activities:

DSI graduated 200 students in 7 schools from an educational program in health and entrepreneurship. Students are equipped to be entrepreneurs in a replication sodium hypochlorite business in Les Cayes, or to start or work in a separate enterprise.
